#### TERMS AND CONDITIONS

By participating in this Family Services Geelong Design Week Babab Nyayl Project, you agree to the following terms and conditions:

#### 1. PROJECT DETAILS

- 1.1 The promoter of the Family Services Geelong Design Week project is the Greater Geelong City Council, 30 Gheringhap Street, Geelong VIC 3220, ABN 18 374 210 672 (City).
- 1.2 The Family Services Geelong Design Week Babab Nyayl project commences at 9:00am on Monday 17 January 2022 and closes at 5:00pm on Friday 11 February 2022. Photos will only be accepted during this period.

#### 2. ENTRIES

- 2.1 Entry is open to persons under 5 years of age but who have parent or guardian consent to enter and are residents of Victoria.
- 2.2 By entering this Family Services Design Week Babab Nyayl project, you warrant to the City that you are eligible to enter based on these terms and conditions.
- 2.3 Entry is deemed acceptance of these terms and conditions. If you do not agree with any part of these terms and conditions you should not participate.
- 2.4 All City employees and are eligible to enter.
- 2.5 Children should be accompanied and supported by a parent or guardian when taking their photos.
- 2.6 The amount of submissions is unlimited, however only one photograph per person will be selected and added to the showreel projection.
- 2.7 Images and text that are considered of an offensive nature will not be accepted.
- 2.8 The City reserves the right, at any time, to verify the validity of photographs and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the City to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 2.9 To enter you must submit a photo of your favourite place in Geelong where you feel a sense of belonging to [Have Your Say Page](#) along with a brief description about your photo and why it gives you a sense of belonging. By posting your photo on the [Babab Nyayl Have Your Say page](#), you are confirming that the photo you are posting (if relevant) is of yourself/and or your child and you have permission to use the image. You are agreeing to the Social Media [Guidelines](#) and you are aware of your responsibilities.
- 2.10 Submissions must include your full name, email address and phone number so we can contact you if required.
- 2.11 The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter the competition repeatedly is prohibited and will render all entries submitted by that entrant invalid.
