

## **SIGN UP TO THE CITY'S HAVE YOUR SAY PLATFORM COMPETITION – TERMS AND CONDITIONS**

By participating in this competition, you agree to the following terms and conditions:

1. The Promoter is the Greater Geelong City Council.
2. The Promoter reserves the right, at any time, to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these Terms and Conditions. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
3. Entry into the competition is limited to one entry per person.
4. Entry is open to any resident of Australia who is 18 years of age and over, or who is between 12 – 18 years of age with parental or guardian consent to enter. Employees of the Promoter and their immediate families, suppliers, associated companies and agencies are ineligible to enter.
5. To enter this competition, you must register as a member on the Promoter's Have Your Say website between 17 February, 2023 and 14 March, 2024. There will be a monthly prize draw and entrants will be eligible for the prize in the month they sign up.
